

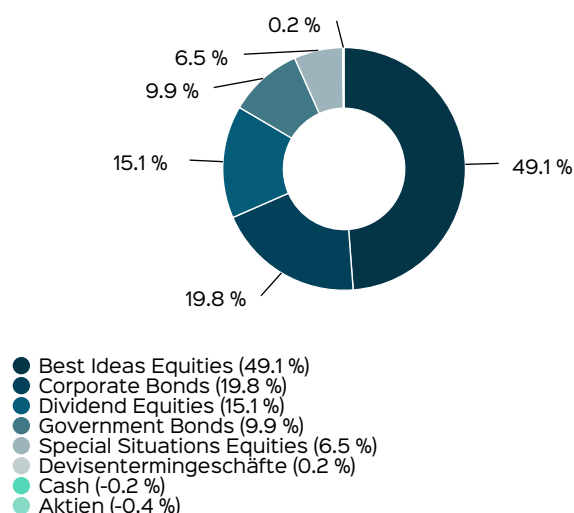

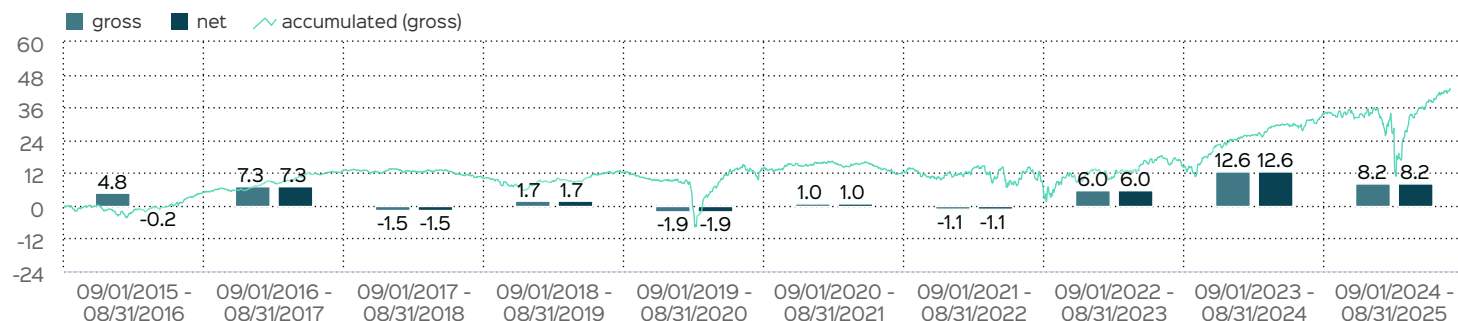
Asset allocation - individual

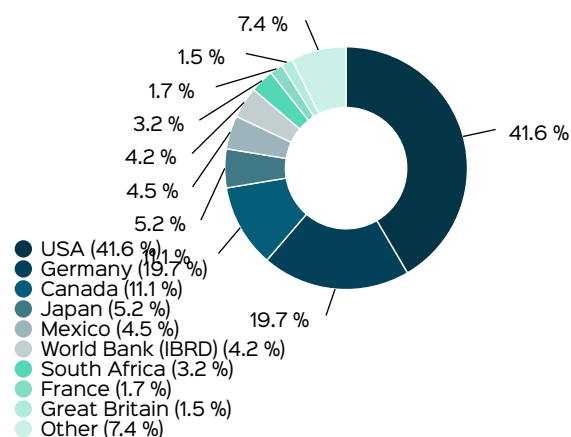

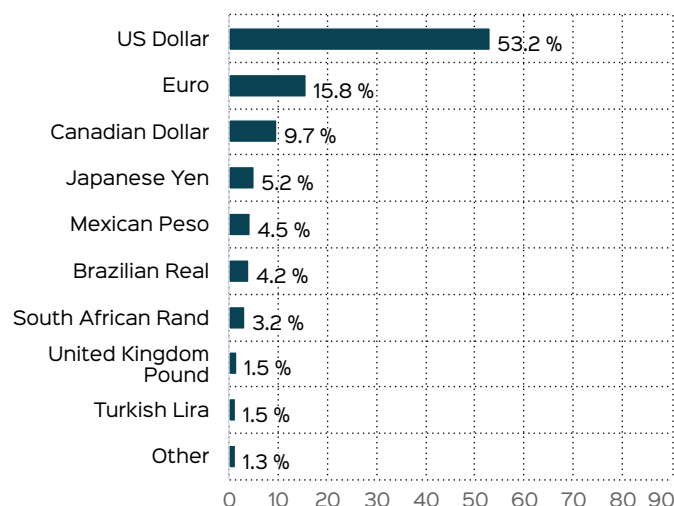
