

In addition, a dynamic hedge is actively used on the basis of a risk model that has been tried and tested over years. Depending on the market situation and the findings of the model, the aim is to achieve a performance similar to that of equities, with phases of low or negative correlation to the equity market. ESG criteria are taken into account throughout the entire investment process.






